Ridley College requires all new students to provide a Police Check and Working with Children Check as part of the application process; this includes Cross Institutional applicants applying for a practical ministry subject, or more than one subject at Ridley College.

All states except the ACT offer online verification of WWCCs; applicants from the ACT must provide a certified copy of their WWVP card. Electronic Police Check results are secure, and do not need to be certified. Any student who has not provided both checks may not be allowed to enrol in further units beyond the first semester.

### **WORKING WITH CHILDREN CHECK**

The volunteer check is free in Victoria. Applicants from Victoria who already hold a WWCC must provide a copy of their card to Ridley College Admissions **and**: go to MyCheck and add Ridley College to their details within 21 days. Applicants from other states must follow the rules for their State system. Registered teachers in Victoria do not require a separate WWCC, but must notify WWCCV of any other child-related activities including your course at Ridley here: https://www.workingwithchildren.vic.gov.au/organisations/victorian-teacher-information
